New Business	Deb Worley: Rubric The current assessment rubric appears to be underperforming. To provide programs with effective feedback the rubric needs improvement. As the members continue to complete reviews, please take notes regarding what is working well and what is not working in the rubric. Some potential areas for improvement: - A different scale - Ability to comment on each section vs. each item - Are there wording issues in the rubric? - What areas caused confusion?
	Soizek Laguette stated there is confusion regarding student learning goals, program goals, and the department mission statement. How should they be addressed in each program? She offered the suggestion of distributing, on the assessment webpage and email to departments at the beginning of the assessment cycle, a summary of what the UAC is looking for and will be evaluating. She also suggested providing examples of well written assessment plans.
	Amber Johnson suggested to complete an orientation during the first UAC meeting yearly to review the entire assessment process, address terminology seen within the rubric, and how to provide effective feedback to the programs.
